# EFFECT OF GENERALIZED RELATIVE ORDER ON THE GROWTH OF COMPOSITE ENTIRE FUNCTIONS

#### Abstract

In this paper we establish some newly developed results related to the growth rates of composite entire functions on the basis of their generalized relative orders and generalized relative lower orders.


## 1. Introduction

Let $f$ be an entire function defined on set of all finite complex numbers C. The maximum modulus $M f(r)$ of $f=\sum_{n=0}^{\infty} a_{n} z^{n}$ on $|z|=r$ is defined by $M_{f}(r)=\max _{|z|=r}|f(z)|$. If $f$ is non-constant entire then $M_{f}(r)$ is strictly increasing and continuous and therefore there exists its inverse function $M_{f}^{-1}:(|f(0)|, \infty) \rightarrow$ $(0, \infty)$ with $\lim _{s \rightarrow \infty} M_{f}^{-1}(s)=\infty$. On the other hand the maximum term $\mu_{f}(r)$ of $f$ can be defined in the following way:

\mu_{f}(r)=\max _{n \geq 0}\left(\left|a_{n}\right| r^{n}\right)
$$

whose inverse is also a increasing function of $r$.
The ratios $\frac{M_{f}(r)}{M_{g}(r)}$ as $r \rightarrow \infty$ and $\frac{\mu_{f}(r)}{\mu_{g}(r)}$ as $r \rightarrow \infty$ are called the growth of $f$ with respect to $g$ in terms of their maximum moduli and the maximum term respectively. And the study of comparative growth properties of entire functions which is one of a prominent branch of the value distribution theory of entire functions is the prime concern of the paper. Our notations are standard within the theory of Nevanlinna's value distribution of entire functions and therefore we do not explain those in detail as available in [15]. In the sequel the following two notations are

Taking this into account the generalized order (respectively, generalized lower order) of an entire function $f$ as introduced by Sato [11] is given by:

\rho_{f}^{[l]}=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} M_{f}(r)}{\log \log M_{\exp z}(r)}=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} M_{f}(r)}{\log r} \\
\left(\text { respectively } \lambda_{f}^{[l]}=\liminf _{r \rightarrow \infty} \frac{\log { }^{[l]} M_{f}(r)}{\log \log M_{\exp z}(r)}=\liminf _{r \rightarrow \infty} \frac{\log { }^{[l]} M_{f}(r)}{\log r}\right)
\end{gathered}
$$

where $l \geq 1$.
These definitions extend the definitions of order $\rho_{f}$ and lower order $\lambda_{f}$ of an entire function $f$ since for $l=2$, these correspond to the particular case $\rho_{f}^{[2]}=\rho_{f}(2,1)=\rho_{f}$ and $\lambda_{f}^{[2]}=\lambda_{f}(2,1)=\lambda_{f}$.

Using the inequality

\mu_{f}(r) \leq M_{f}(r) \leq \frac{R}{R-r} \mu_{f}(R)\{c f .[13]\} \text { for } 0 \leq r<R
$$

the growth indicator $\rho_{f}$ ( respectively $\lambda_{f}$ ) and consequently $\rho_{f}^{[l]}\left(\right.$ respectively $\left.\lambda_{f}^{[l]}\right)$ are reformulated as:

\rho_{f}=\limsup _{r \rightarrow \infty} \frac{\log ^{[2]} \mu_{f}(r)}{\log r}\left(\text { respectively } \lambda_{f}=\liminf _{r \rightarrow \infty} \frac{\log ^{[2]} \mu_{f}(r)}{\log r}\right)
$$

and

$$
\rho_{f}^{[l]}=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{f}(r)}{\log r}\left(\text { respectively } \lambda_{f}^{[l]}=\liminf _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{f}(r)}{\log r}\right)
$$

where $l \geq 1$.
For any two entire functions $f$ and $g$, Bernal $\{[1],[2]\}$ introduced the definition of relative order of $f$ with respect to $g$, denoted by $\rho_{g}(f)$ as follows:

\rho_{g}(f) & =\inf \left\{\mu>0: M_{f}(r)<M_{g}\left(r^{\mu}\right) \text { for all } r>r_{0}(\mu)>0\right\} \\
& =\limsup _{r \rightarrow \infty} \frac{\log M_{g}^{-1} M_{f}(r)}{\log r}
\end{aligned}
$$

which avoid comparing growth just with $\exp z$ to determine order of entire functions as we see in the earlier and naturally this definition coincides with the classical one [14] for $g=\exp z$.

Similarly, one can define the relative lower order of $f$ with respect to $g$ denoted by $\lambda_{g}(f)$ as

\lambda_{g}(f)=\liminf _{r \rightarrow \infty} \frac{\log M_{g}^{-1} M_{f}(r)}{\log r}
$$

In the case of relative order, it therefore seems reasonable to state suitably an alternative definition of relative order of entire function in terms of its maximum terms. Datta and Maji [6] introduced such a definition in the following way:

Definition 1. [6] The relative order $\rho_{g}(f)$ and the relative lower order $\lambda_{g}(f)$ of an entire function $f$ with respect to another entire function $g$ are defined as follows:

\rho_{g}(f)=\limsup _{r \rightarrow \infty} \frac{\log \mu_{g}^{-1} \mu_{f}(r)}{\log r} \text { and } \lambda_{g}(f)=\liminf _{r \rightarrow \infty} \frac{\log \mu_{g}^{-1} \mu_{f}(r)}{\log r}
$$

Lahiri and Banerjee [10] gave a more generalized concept of relative order in the following way:
Definition 2. [10] If $l \geq 1$ is a positive integer, then the $l$ - th generalized relative order of $f$ with respect to $g$, denoted by $\rho_{f}^{l}(g)$ is defined by

& =\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} M_{g}^{-1} M_{f}(r)}{\log r}
\end{aligned}
$$

Clearly $\rho_{g}^{1}(f)=\rho_{g}(f)$ and $\rho_{\exp z}^{1}(f)=\rho_{f}$.
Likewise, one can define the generalized relative lower order of $f$ with respect to $g$ denoted by $\lambda_{g}^{[l]}(f)$ as

\lambda_{g}^{[l]}(f)=\liminf _{r \rightarrow \infty} \frac{\log ^{[l]} M_{g}^{-1} M_{f}(r)}{\log r}
$$

In terms of maximum terms of entire functions, Definition 2 can be reformulated as:

Definition 3. For any positive integer $l \geq 1$, the growth indicators $\rho_{g}^{[l]}(f)$ and $\lambda_{g}^{[l]}(f)$ for an entire function $f$ are defined as:
$\rho_{g}^{[l]}(f)=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{g}^{-1} \mu_{f}(r)}{\log r}$ and $\lambda_{g}^{[l]}(f)=\liminf _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{g}^{-1} \mu_{f}(r)}{\log r}$.
In fact, Lemma 6 states the equivalence of Definition 2 and Definition 3.

For entire functions, the notions of the growth indicators such as order is classical in complex analysis and during the past decades, several researchers have already been exploring their studies in the area of comparative growth properties of composite entire functions in different directions using the classical growth indicators. But at that time, the concepts of relative orders and consequently the generalized relative orders of entire functions and as well as their technical advantages of not comparing with the growths of $\exp z$ are not at all known to the researchers of this area. Therefore the growth of composite entire functions needs to be modified on the basis of their relative order some of which has been explored in [4], [5], [6], [7], [8] and [9]. In this paper we establish some newly developed results related to the growth rates of composite entire functions on the basis of their generalized relative orders ( respectively generalized relative lower orders).

## 2. Lemmas

In this section we present some lemmas which will be needed in the sequel.
Lemma 1. [12] Let $f$ and $g$ be any two entire functions Then for every $\alpha>1$ and $0<r<R$,

\mu_{f \circ g}(r) \leq \frac{\alpha}{\alpha-1} \mu_{f}\left(\frac{\alpha R}{R-r} \mu_{g}(R)\right)
$$

Lemma 2. [12] If $f$ and $g$ are any two entire functions with $g(0)=0$. Then for all sufficiently large values of $r$,

\mu_{f \circ g}(r) \geq \frac{1}{2} \mu_{f}\left(\frac{1}{8} \mu_{g}\left(\frac{r}{4}\right)-|g(0)|\right)
$$

Lemma 3. [3] If $f$ and $g$ are two entire functions then for all sufficiently large values of $r$,

$$
M_{f}\left(\frac{1}{8} M_{g}\left(\frac{r}{2}\right)-|g(0)|\right) \leq M_{f \circ g}(r) \leq M_{f}\left(M_{g}(r)\right)
$$

Lemma 4. [2] Suppose that $f$ be an entire function and $\alpha>1,0<\beta<\alpha$. Then for all sufficiently large $r$,

$$
M_{f}(\alpha r) \geq \beta M_{f}(r)
$$

Lemma 5. [6] If $f$ be an entire and $\alpha>1,0<\beta<\alpha$, then for all sufficiently large $r$,

$$
\mu_{f}(\alpha r) \geq \beta \mu_{f}(r)
$$

Lemma 6. Definition 2 and Definition 3 are equivalent.
Proof. Taking $R=\alpha r$ in the inequalities $\mu_{h}(r) \leq M_{h}(r) \leq \frac{R}{R-r} \mu_{h}(R)\{c f$. [13] $\}$, for $0 \leq r<R$ we obtain that

M_{h}^{-1}(r) \leq \mu_{h}^{-1}(r)
$$

and

\mu_{h}^{-1}(r) \leq \alpha M_{h}^{-1}\left(\frac{\alpha r}{(\alpha-1)}\right)
$$

Since $M_{h}^{-1}(r)$ and $\mu_{h}^{-1}(r)$ are increasing functions of $r$, then for any $\alpha>1$ it follows from the above and the inequalities $\mu_{f}(r) \leq M_{f}(r) \leq \frac{\alpha}{\alpha-1} \mu_{f}(\alpha r)\{c f$. [13] $\}$ that

M_{h}^{-1} M_{f}(r) \leq \mu_{h}^{-1}\left[\frac{\alpha}{(\alpha-1)} \mu_{f}(\alpha r)\right] \tag{1}
\end{equation*}
$$

and

\mu_{h}^{-1} \mu_{f}(r) \leq \alpha M_{h}^{-1}\left[\frac{\alpha}{(\alpha-1)} M_{f}(r)\right] \tag{2}
\end{equation*}
$$

Therefore in view of Lemma 5 we have from (1) that

M_{h}^{-1} M_{f}(r) \leq \mu_{h}^{-1} \mu_{f}\left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]
$$

Thus from above we get that

$$
\begin{array}{r}
\frac{\log ^{[l]} M_{g}^{-1} M_{f}(r)}{\log r} \leq \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}\left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]}{\log r} \\
\text { i.e., } \frac{\log ^{[l]} M_{g}^{-1} M_{f}(r)}{\log r} \leq \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}\left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]}{\log \left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]+O(1)} \\
\text { i.e. } \rho_{g}^{[l]}(f)=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} M_{g}^{-1} M_{f}(r)}{\log r} \\
\leq \limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}\left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]}{\log \left[\frac{(2 \alpha-1) \alpha}{(\alpha-1)} \cdot r\right]+O(1)} \\
\text { i.e., } \rho_{g}^{[l]}(f) \leq \limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \tag{3}
\end{array}
$$

and accordingly

$$

\lambda_{g}^{[l]}(f) \leq \liminf _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \tag{4}
\end{equation*}
$$

Similarly, in view of Lemma 4 it follows from (2) that

\mu_{h}^{-1} \mu_{f}(r) \leq \alpha M_{h}^{-1} M_{f}\left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]
$$

and from above we obtain that

$$

\frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \leq \frac{\log ^{[l]} \alpha M_{h}^{-1} M_{f}\left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]}{\log r} \\
\text { i.e., } \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \leq \frac{\log ^{[l]} M_{h}^{-1} M_{f}\left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]+O(1)}{\log \left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]+O(1)} \\
\text { i.e. } \rho_{g}^{[l]}(f)=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} M_{h}^{-1} M_{f}\left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]+O(1)}{\log \left[\left(\frac{2 \alpha-1}{\alpha-1}\right) \cdot r\right]+O(1)} \\
\geq \limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \\
\text { i.e., } \rho_{g}^{[l]}(f) \geq \limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \tag{5}
\end{gather*}
$$

and consequently

$$
\begin{equation*}
\lambda_{g}^{[l]}(f) \geq \liminf _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{h}^{-1} \mu_{f}(r)}{\log r} \tag{6}
\end{equation*}
$$

Combining (3), (5) and (4), (6) we obtain that

\rho_{g}^{[l]}(f)=\limsup _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{g}^{-1} \mu_{f}(r)}{\log r} \text { and } \lambda_{g}^{[l]}(f)=\liminf _{r \rightarrow \infty} \frac{\log ^{[l]} \mu_{g}^{-1} \mu_{f}(r)}{\log r}
$$

This proves the lemma.

## 3. Main Results

In this section we present the main results of the paper.
Theorem 1. Let $f, g$ and $h$ be any three entire functions such that $\lambda_{g}^{[q]}<\lambda_{h}^{[p]}(f) \leq$ $\rho_{h}^{[p]}(f)<\infty$ where $p$ and $q$ are any two positive integers with $p>1$ and $q>2$. Then
(i) $\liminf _{r \rightarrow \infty} \frac{\log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r)}{\log ^{[p-q+1]} \mu_{h}^{-1} \mu_{f}(r)}=0$
and
(ii) $\liminf _{r \rightarrow \infty} \frac{\log ^{[p]} M_{h}^{-1} M_{f \circ g}(r)}{\log ^{[p-q+1]} M_{h}^{-1} M_{f}(r)}=0$.

Proof. Since $\mu_{h}^{-1}(r)$ is an increasing function of $r$, taking $R=\beta r(\beta>1)$ in Lemma 1 and in view of Lemma 5 it follows for a sequence of values of $r$ tending to infinity that

\mu_{f \circ g}(r) & \leq \frac{\alpha}{\alpha-1} \mu_{f}\left(\frac{\alpha \beta}{(\beta-1)} \mu_{g}(\beta r)\right) \\
\text { i.e., } \mu_{f \circ g}(r) & \leq \mu_{f}\left(\frac{(2 \alpha-1) \alpha \beta}{(\alpha-1)(\beta-1)} \mu_{g}(\beta r)\right) \\
\text { i.e., } \log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r) & \leq \log ^{[p]} \mu_{h}^{-1} \mu_{f}\left(\frac{(2 \alpha-1) \alpha \beta}{(\alpha-1)(\beta-1)} \mu_{g}(\beta r)\right)  \tag{7}\\
\text { i.e., } \log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r) & \leq\left(\rho_{h}^{[p]}(f)+\varepsilon\right) \exp ^{[q-2]}(\beta r)^{\lambda_{g}^{q q]}}+\varepsilon  \tag{8}\\
& O(1) .
\end{align*}
$$

Again from Definition 3, we obtain for all sufficiently large values of $r$ that

$$
\begin{equation*}
\log ^{[p-q+1]} \mu_{h}^{-1} \mu_{f}(r) \geqslant \exp ^{[q-2]} r_{h}^{\lambda_{h}^{[p]}(f)-\varepsilon} \tag{9}
\end{equation*}
$$

Now in view of (8) and (9), we get for a sequence of values of $r$ tending to infinity that

$$
\begin{equation*}
\frac{\log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r)}{\log ^{[p-q+1]} \mu_{h}^{-1} \mu_{f}(r)} \leq \frac{\left(\rho_{h}^{[p]}(f)+\varepsilon\right) \exp ^{[q-2]}(\beta r)^{\lambda_{g}^{[q]}+\varepsilon}+O(1)}{\exp ^{[q-2]} r_{h}^{\lambda_{h}^{[p]}(f)-\varepsilon}} \tag{10}
\end{equation*}
$$

Since $\lambda_{g}^{[q]}<\lambda_{h}^{[p]}(f)$, we can choose $\varepsilon(>0)$ in such a way that $\lambda_{g}^{[q]}+\varepsilon<\lambda_{h}^{[p]}(f)-\varepsilon$ and therefore, first part of the theorem follows from (10).

As $M_{h}^{-1}(r)$ is an increasing function of $r$, by similar reasoning as above the second part of the theorem follows from the second part of Lemma 3 and therefore its proof is omitted.

Remark 1. If we take $\rho_{g}^{[q]}<\lambda_{h}^{[p]}(f) \leq \rho_{h}^{[p]}(f)<\infty$ instead of $\lambda_{g}^{[q]}<\lambda_{h}^{[p]}(f) \leq$ $\rho_{h}^{[p]}(f)<\infty$ and the other conditions remain the same, the conclusion of Theorem 1 remains valid with"limit inferior" replaced by "limit".

Theorem 2. Let $f, g$ and $h$ be any three entire functions such that $0<\lambda_{h}^{[p]}(f) \leq$ $\rho_{h}^{[p]}(f)<\infty$ and $\lambda_{g}^{[q]}<\infty$ where $p, q$ are any integers with $p \geq 1$ and $q \geq 2$. Then for every positive constant $A$ and each $\alpha \in(-\infty, \infty)$,
(i) $\liminf _{r \rightarrow \infty} \frac{\left\{\log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r)\right\}^{1+\alpha}}{\log ^{[p]} \mu_{h}^{-1} \mu_{f}\left(\exp { }^{[q-1]} r^{A}\right)}=0$ if $A>(1+\alpha) \lambda_{g}^{[q]}$
and
(ii) $\liminf _{r \rightarrow \infty} \frac{\left\{\log ^{[p]} M_{h}^{-1} M_{f \circ g}(r)\right\}^{1+\alpha}}{\log ^{[p]} M_{h}^{-1} M_{f}\left(\exp ^{[q-1]} r^{A}\right)}=0$ if $A>(1+\alpha) \lambda_{g}^{[q]}$.

Proof. If $1+\alpha \leq 0$, then the theorem is obvious. We consider $1+\alpha>0$.
Now from the definition of generalized relative lower order, we get for all sufficiently large values of $r$ that

\log ^{[p]} \mu_{h}^{-1} \mu_{f}\left(\exp ^{[q-1]} r^{A}\right) \geq\left(\lambda_{h}^{[p]}(f)-\varepsilon\right) \exp ^{[q-2]} r^{A} \tag{11}
\end{equation*}
$$

Therefore we get from (8) and (11), for a sequence of values of $r$ tending to infinity that

$$
\begin{gather*}
\frac{\left\{\log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r)\right\}^{1+\alpha}}{\log ^{[p]} \mu_{h}^{-1} \mu_{f}\left(\exp ^{[q-1]} r^{A}\right)} \leq \frac{\left(\rho_{h}^{[p]}(f)+\varepsilon\right)^{1+\alpha} \cdot \exp ^{[q-2]}(\beta r)^{\left(\lambda_{g}^{[q]}+\varepsilon\right)(1+\alpha)}}{\left(\lambda_{h}^{[p]}(f)-\varepsilon\right) \exp ^{[q-2]} r^{A}} \\
\times\left[1+\frac{O(1)}{\left(\rho_{h}^{[p]}(f)+\varepsilon\right)^{1+\alpha} \cdot \exp ^{[q-2]}(\beta r)^{\left(\lambda_{g}^{[q]}+\varepsilon\right)(1+\alpha)}}\right]^{(1+\alpha)}, \tag{12}
\end{gather*}
$$

where we choose $0<\varepsilon<\min \left\{\lambda_{h}^{[p]}(f), \frac{A}{1+\alpha}-\lambda_{g}^{[q]}\right\}$. So from (12) we obtain that

$$
\liminf _{r \rightarrow \infty} \frac{\left\{\log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r)\right\}^{1+\alpha}}{\log ^{[p]} \mu_{h}^{-1} \mu_{f}\left(\exp ^{[q-1]} r^{A}\right)}=0 .
$$

This proves the first part of the theorem.
Similarly, the second part of the theorem can be carried out using the same technique as above and with the help of Lemma 3. Therefore its proof is omitted.

In view of Theorem 2, the following theorem can be carried out:
Theorem 3. Let $f, g, h$ and $k$ be any four entire functions with $\rho_{h}^{[p]}(f)<\infty$, $\lambda_{g}^{[q]}<\infty$ and $\lambda_{k}^{[m]}(g)>0$ where $p, q, m$ are any three integers with $p \geq 1, q \geq 2$ and $m \geq 1$. Then for every positive constant $A$ and each $\alpha \in(-\infty, \infty)$,

and
(ii) $\liminf _{r \rightarrow \infty} \frac{\left\{\log ^{[p]} M_{h}^{-1} M_{f \circ g}(r)\right\}^{1+\alpha}}{\log ^{[m]} M_{k}^{-1} M_{g}\left(\exp ^{[q-1]} r^{A}\right)}=0$ if $A>(1+\alpha) \lambda_{g}^{[q]}$.

The proof is omitted.

& \text { i.e., } \log ^{[p]} \mu_{h}^{-1} \mu_{f \circ g}(r) \geq\left(\lambda_{h}^{[p]}(f)-\varepsilon\right) \exp ^{[q-2]}\left(\frac{r}{4}\right)^{\rho_{g}^{[q]}-\varepsilon}+O(1) . \tag{24}

& i . e ., ~ \log ^{[p-1]} \mu_{h}^{-1} \mu_{f \circ g}(r) \geqslant\left\{\log ^{[p-1]} \mu_{h}^{-1} \mu_{f}\left(\exp ^{[q-1]} r^{A}\right)\right\}^{K}
\end{aligned}
$$

from which the first part of the theorem follows.
Accordingly the second part of the theorem can be deduced with the help of the first part of Lemma 3 and therefore its proof is omitted.

Analogously the following theorem can be carried out in the line of Theorem 15:
Theorem 15. Let $f, g, h$ and $k$ be any four entire functions with $\lambda_{h}^{[p]}(f)>0$ and $\rho_{k}^{[m]}(g)<\infty$ where $p, m$ are any positive integers. Then for every positive constant $A$ such that $0<A<\lambda_{g}^{[q]}$ for any positive integer $q>1$,

\text { (ii) } \lim _{r \rightarrow \infty} \frac{\log ^{[p]} M_{h}^{-1} M_{f \circ g}(r)}{\log { }^{[m]} M_{k}^{-1} M_{g}\left(\exp ^{[q-1]} r^{A}\right)}=\infty
$$

The proof is omitted.
